

Cherry Creek Gun Club Membership Application

Prospective Members: Please, read this section First!

Cherry Creek Gun Club, Inc. (CCGC) is a private indoor precision handgun and rifle shooting Club located in an un-incorporated section of Arapahoe County in the East Denver metro area. The Club is an all-volunteer organization and facility.

CCGC facilities are available to members 24 hours a day, 7 days a week, 365 days a year, consisting of two 10-lane handgun ranges, each 25-yards long (3 are magnum pistol rated), and a two-position 100-yard rifle range. Our controlled access facility is not open to the public, and we do not sell or rent firearms, ammunition, or have gunsmithing services.

CCGC welcomes new member inquiries. A comprehensive background check and safety orientations are required as part of the application process. We have several types of memberships available, and members may bring guests with certain limitations.

New members must demonstrate that they have prior basic experience, knowledge, and skills in the Safe use of their firearms prior to becoming members of the Club. At this time, CCGC has No shooting instruction classes of any type scheduled.

We are an NRA (National Rifle Association) affiliated Club and each Club member must also be a current member of the NRA. All CCGC members must have an NRA membership that will extend through the entire CCGC Membership year at each renewal period. New members are suggested to get at least a minimum of two-years of NRA membership to ease their first CCGC renewal if they are not presently NRA members. Note that the NRA offers a discount for dues fees when purchased through the link <https://membership.nra.org/recruiters/join/XC018056> on the CCGC Website.

Programs include Bullseye/2700 precision handgun shooting, bowling pin shooting, state handgun matches, Colorado Parks and Wildlife Hunter Education classes, as well as an active Juniors marksmanship program.

Note that CCGC is NOT the shooting range at Cherry Creek State Park (The Family Shooting Center), although the two are frequently confused.

Please read the following basic rules to ensure that your expectations of what activities CCGC allows and doesn't allow will fit with your desires.

The following are Primary CCGC & Range Rules and items that are PROHIBITED:

No "Quick Draw: (Drawing a firearm and then shooting on the draw) or "Holster" work including rapid magazine changes or drawing a concealed firearm and then shooting on the draw.

No moving while shooting any firearm.

No shooting across lanes.

Prospective Cherry Creek Gun Club membership applicants.

The following are Primary CCGC & Range Rules and items that are PROHIBITED:

Only Paper Targets are allowed except during Club supervised events. All targets must be placed at a height such that all projectiles passing through the target will hit the proper section of the range back stop.

No Steel Projectile ammunition. (Red Block style ammunition)

No Armor piercing, Tracer or Incendiary ammunition allowed in any range.

No Use of fully automatic firearms, bump stocks, binary triggers or other devices that increase the speed of the trigger or firing action.

No Shotguns on any range with the exception of approved slugs in the rifle range.

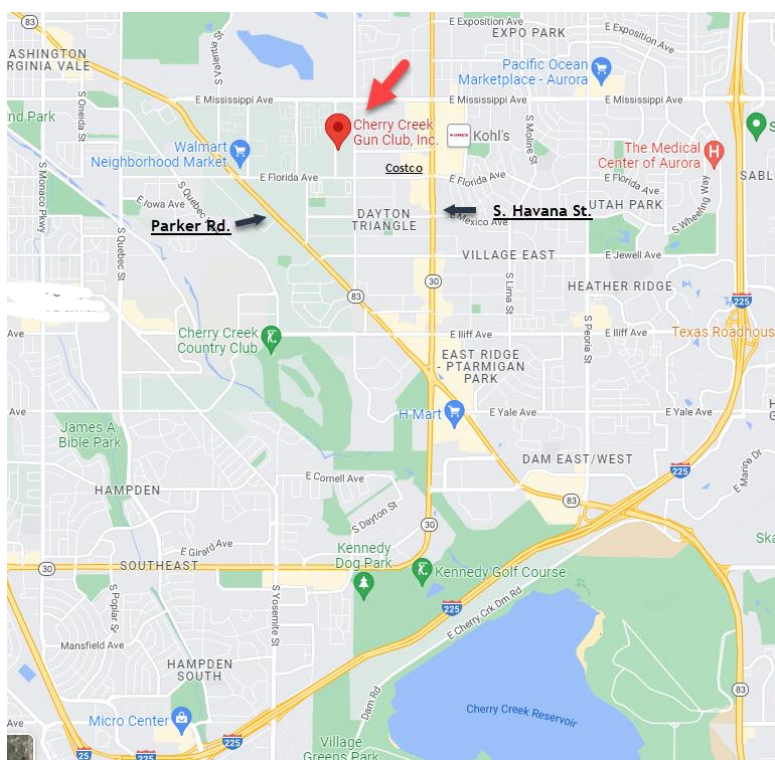
No shot shells or multi-projectile cartridges are allowed on either the handgun ranges or in the Rifle range.

Firearms and ammunition are not allowed in the handgun ranges unless listed as an approved cartridge in the posted Handgun Range Rules.

No training activities are allowed in the ranges or Club room where the trainer receives any compensation for the training.

Cherry Creek Gun Club, Inc. – Membership Requirements

(10/28/2022)

This document describes the application process and requirements for membership in the Cherry Creek Gun Club. This application and the Club By-laws and Policies document are available on the Club's website <https://cherrycreekgunclub.org> and should be read and understood in their entirety before applying for membership. If the prospective member has any questions regarding Club membership, policies, fees, etc. these questions should be answered prior to application by speaking to a Club Board Member or by e-mailing the Membership Coordinator, CCGC-Membership@comcast.net

Requirements

Cherry Creek Gun Club policies require every prospective member to agree to a background check administered by the Club. All information gathered in this process is kept confidential and will determine membership eligibility. This check is to ensure that new members are legally able to own, possess, and use a firearm as described by Federal and Colorado State Laws.

Cherry Creek Gun Club policy also requires that an applicant complete a club and safety orientation given by an NRA Certified Range Safety Officer to ensure the safety of the Club, its members, and its guests.

The Application Process

Step 1 - The applicant presents the completed application together with a color copy of a current Driver's License or official ID and a copy of an up-to-date NRA card or document showing the NRA Membership Number and Expiration Date to the end of the year, and a check for the application fee to the Club at a General Meeting held the second Friday of each month, OR mail the application.

Dues are prorated from the month you are voted into the club

Family Dependent or Sponsored Junior does not need to fill out Applicant Release Authorization form

Step 2 - The information provided by the prospective member is used to run the required background check.

Step 3 - The results of the background check are returned to the membership staff for review.

Step 4 – The application decision will be provided to the prospective member by club membership staff. Applicants will be notified with email directing them how to proceed with the Membership Process.

Step 5 – The applicant will be instructed to contact one of the Club's NRA Certified Range Safety Officers to complete the club and safety orientation. ~~prior to the General Meeting~~. The Safety Orientation consists of you demonstrating your familiarity with, and safe handling of a handgun. It must be completed prior to you receiving Club membership access. It also includes a briefing on all aspects of the Club and rules and regulations. You must bring a handgun and ammunition with you when you attend the orientation. Eye and ear protection is also required. Use of the rifle tube will require a different and subsequent orientation.

THIS IS THE APPLICANT'S RESPONSIBILITY TO COMPLETE!

Step 6 – The applicants, who have passed the background check, attended and completed the club and safety orientation will be invited to the next General Meeting, held the second Friday of each month at 7:00 PM, for consideration and final acceptance by the Club Membership.

Step 7 – National Rifle Association

The Cherry Creek Gun Club is affiliated with the National Rifle Association. To be a member of the Cherry Creek Gun Club, you must provide proof of a current NRA Membership, which is required for the application. Your NRA membership must be maintained to be continuous through each subsequent annual membership renewal year. If you are not currently a member, you must join the NRA. When you join the NRA, they will provide a receipt for application and this can serve as temporary proof of NRA Membership. Upon receiving your official NRA Membership card and number you are required to provide this to the Membership Coordinator.

You may join the NRA by going to CCGC Club's NRA link, <https://membership.nra.org/recruiters/join/XC018056> If you go to our web site you will receive a \$10.00 discount for joining through the club. Additional savings for multiple year NRA Memberships are also available when you go through the club website and are suggested. If you choose, you can use the NRA link, <http://nra.org>.

Applicants whose application has been declined based on the results of the background check will be refunded the Dues Fees. **APPLICATION FEES ARE NON-REFUNDABLE**

RELEASE AND WAIVER OF LIABILITY

As a Member or guest of Cherry Creek Gun Club, Inc. (hereafter, "CCGC") I state that I have read and agree to the following:

NO MEMBER OR GUEST IS PERMITTED ON CCGC PROPERTY UNLESS AND UNTIL THEY HAVE SIGNED THIS RELEASE AND WAIVER OF LIABILITY, AND WILL BE A TRESPASSER UNTIL IT IS SIGNED.

I have read and understand the NRA Safety Gun Handling Rules, which are:

- Always keep the gun pointed in a safe direction
- Always keep your finger off the trigger until you are ready to shoot
- Always keep your gun unloaded until ready to use

While at the Cherry Creek Gun Club you must also:

- Be sure of your target, and what is behind it

I agree to obey these rules and all rules of CCGC at all times while engaging in shooting sports while on CCGC property, or any event supported by or sponsored by CCGC.

I am familiar with safe firearms handling and use, and the safe use of each firearm I may use while engaging in shooting sports while on CCGC property, or any event supported by or sponsored by CCGC.

I state and agree that I have received adequate training in the safe use of firearms, and of each firearm I use, before using any firearm on CCGC property, or any event supported by or sponsored by CCGC.

As a better practice, I understand that CCGC encourages each Member or guest to uncase each firearm at the shooting station, pointing the muzzle down range at all times, and to similarly return the firearm to the case at the shooting station at the end of the shooting session, and to not have an uncased firearm on the premises.

I swear or affirm that I am lawfully in possession of a firearm at all times that I may be on CCGC property, now or in the future, and I understand that I am not permitted on the property of CCGC, or to participate in any event supported or sponsored by CCGC, if I am not lawfully permitted to be in possession of a firearm.

I agree to be fully responsible for safe firearms handling of each guest I may bring to CCGC, to make each guest aware of the rules of safe firearm handling and of CCGC rules, and I agree to ensure that each of my guests follows these rules at all times.

I agree to have no firearm uncased while outside the building while I am on CCGC property.

I understand that the use and handling of firearms is a dangerous activity, including the risk of property damage, personal injury or death to me or others, and I knowingly and with full appreciation of these risks hereby waive, release, hold harmless, and covenant not to sue CCGC, its officers, directors, employees, agents, insurers, attorneys, successors or assigns, or any and all others acting on behalf of CCGC (collectively referred to hereafter as "CCGC"), from any claims, suits, actions, causes of action, damages, or liability of any kind for property damage, injury or death to me while I am engaging in the use or handling of firearms, or while engaging in shooting sports while on CCGC property, or any event supported by or sponsored by CCGC.

If I, as the parent of a minor, permit a minor to participate in any use or handling of firearms, or to engage in shooting sports while on CCGC property, or any event supported by or sponsored by CCGC, I hereby indemnify and hold harmless CCGC, its officers, directors, employees, agents, insurers, attorneys, successors or assigns, and/or any and all others acting on behalf of CCGC from any and all damage, injury or death to said minor, and agree to pay all damages or judgments entered against CCGC by or on behalf of the minor, including attorney fees and court costs of CCGC, relating to the minor while he or she is engaging in such activities.

I have read and understood the CCGC Range & Safety Rules and agree to strictly adhere to the requirements contained therein.

I represent I have no medical, psychological, or other conditions, which would prevent my participation in the safe use of CCGC facilities.

I understand and agree to familiarize myself with and strictly abide by all CCGC policies, rules, regulations and operating procedures.

I understand and acknowledge I am a voluntary participant in the utilization of CCGC facilities and I agree that the discharge of firearms carries serious risk and that I am solely responsible for evaluating and assessing that risk.

I expressly understand and agree the use of CCGC facilities presents risks to my physical safety and property. It is my intent this assumption of risk shall be legally binding and constitute a complete bar to myself, my heirs, estate, personal representatives, relatives, executors, employers, agents, insurers, assigns and attorneys. This assumption of risk applies to all activities arising out of, associated with or resulting directly or indirectly from my use of the CCGC facility including parking lot.

As a condition of membership, I agree to a release of claims binding myself, heirs, estate, personal representatives, relatives, executors, employers, agents, insurers, assigns and attorneys. This release applies to any and all claims, which may arise from any cause whatsoever, including any negligent in intentional acts or omissions by myself or other users of the CCGC facilities. I agree CCGC assumes no responsibility for any liability, damage, or injury that may be caused by myself or other users of the CCGC facilities.
